PUBLIC NOTICE

This is to bring to the notice of general public and person(s) holding demat account(s) with Karvy Stock Broking Limited (**KSBL**) that Participanship of KSBL, having DP IDs: IN300394, IN301557, IN301926, and IN302470, was terminated by NSDL in accordance with Bye Law 6.5.1. of NSDL Bye Laws with effect from December 31, 2020, which date was first extended to January 15, 2021, and then, further extended to February 28, 2021.

It was also advised to the demat account holder(s) to shift the securities held in demat account(s) with KSBL to other demat account of his/her/its choice by February 28, 2021. As the demat accounts are still held with KSBL, after an evaluation and selection by the Joint Committee of Market Infrastructure Institutions (MIIs), it has been decided to nominate IIFL Securities Limited (**IIFL**), a Depository Participant of NSDL, to manage these demat accounts. Accordingly, the demat accounts held with KSBL under DP IDs: IN300394, IN301557, IN301926 and IN302470 will be transferred to IIFL on or after March 18, 2021, in terms of Bye Law 6.5.4(vii) of NSDL Bye Laws. However, till the time, the demat accounts held with KSBL are transferred to IIFL, the account holders may submit request to KSBL in prescribed form for transferring the securities to their other demat account. A separate communication has also been sent directly to the account holder(s) by NSDL on March 4, 2021.

In case the account holder(s) wish to continue with the same demat account(s) with the nominated DP i.e. IIFL and have not submitted closure-cum-transfer request to KSBL before March 18, 2021, the same shall be deemed to be an election by account holder(s) to be a client of IIFL and accordingly, after March 18, 2021, these demat account(s) will be managed by IIFL.

It is also informed that on transfer of demat accounts from KSBL to IIFL, the account holder(s) should take necessary steps and shall approach IIFL for operating their demat account(s).
